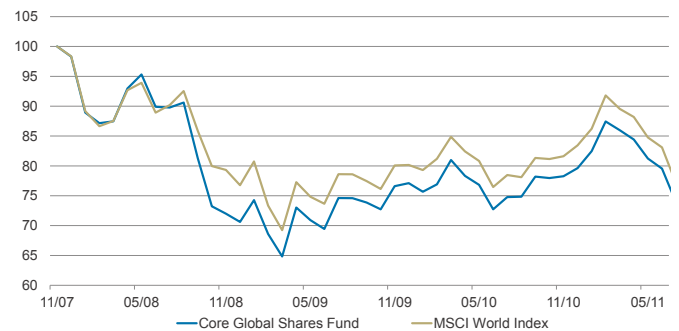
To provide a gross return above the return of the Morgan Stanley Capital International (MSCI) World Accumulation Index with net dividends reinvested on a rolling three year basis.
